Apac District Local Government invites sealed bids from interested and competent Companies /Firms to be pre-qualified /short listed for works, Services and Supplies and Annual Frame work contracts for the Financial Year 2018/19.

SUPPLIES:

- 1: Supply of Ordinary and Executive Office furniture and fittings for Schools and Offices.
- 2: Supply of Office Equipments and tools eg computers, printers, copiers, and accessories.
